SEX SELECTION OPTIONS IN THE UNITED STATES OF AMERICA



For parents want to have either a male or a female baby as an option, we offer the following program

PROGRAM DETAILS:

The program includes a routine IVF program for a couple using the wife's own eggs and the husband's sperm followed by sex selection of the frozen embryos, prior to transfer.



The cost would be:

- **Agency fees: \$5,000. +**
- **Routine IVF with own eggs and partner's sperm: \$24,760 +**
 - patient screening;
 - ovarian stimulation and monitoring;
 - stimulation medications;
 - egg retrieval under sedation/anesthesia;
 - sperm collection;
 - IVF/ICSI;
 - embryo culture to the blastocyst stage;
 - embryo freezing;
 - one frozen embryo transfer.

- **PGT-A: \$1,000 per embryo biopsied and tested.**

For example, if 4 embryos are biopsied and tested, the total cost would be **\$33,760** (\$5,000 agency fee + \$24,760 IVF package + \$4,00 PGT-A).

Regarding the stay in USA, for an IVF cycle with PGT-A we would generally recommend **two trips**.

The **first trip** would be for ovarian stimulation, monitoring, egg retrieval, sperm collection and embryo creation. The wife would generally need to stay approximately **12–14 days**.

The wife may want to work with a local IVF Clinic to start the stimulation using a protocol we can send the wife, to reduce the stay time to about 5-7 days.

After the embryos reach the blastocyst stage, they are biopsied for PGT-A and frozen while the results are pending.

The **second trip** can be a few weeks in the future and be for the frozen embryo transfer after the PGT-A results are available. This stay would be considerably shorter, generally around **3–5 days**.

The husband would normally only need to be present during the first trip to provide the sperm sample and would not usually need to return for the embryo-transfer visit.

The exact treatment schedule and length of stay may vary depending on the patient's individual cycle and medical protocol, so our reproductive specialist will confirm the final timeline for each couple.
